
Kali – A Dying River

6 MAJOR DAMS, A NUCLEAR POWER PLANT, PAPER MILL AND NOW ANOTHER DAM?

polluted by the Dandeli Paper Mills which releases its untreated effluents directly into the river. In addition to damming and pollution, there is also the threat of further illegal sand mining that is continuing on a rampant scale in the Supa Dam area, resulting in serious disturbances to the river's ecology.

Facts

Due to the proposed dam by MPCL, the last stretch of the Kali that is flowing freely will now be lost for posterity. The dam will generate only 18 MW of electricity but at the cost of submerging 210 ha of forests along the Kali. Over 32,000 acres of forests have already been submerged in Uttara Kannada to build the six hydroelectric dams that generate over 1200 MW of electricity. Construction of this new dam is also a significant violation of the 19th May 1987 Government of Karnataka order (No. FFD 242 FGL 83) that no further projects involving diversion of forest land for other uses will be undertaken on Kali River or its tributaries. The latest Supreme Court decisions have upheld the spirit of this order.

Legally this project has to be abandoned: the proponent along with its consultants are guilty of presenting two fraudulent Environment Impact Assessments (EIAs), one by Ernst and Young, and thereafter by Tata Energy Research Institute (TERI). Environment Support Group and Parisara Samrakshana Kendra exposed both during 2000, and as per the EIA Notification, this is definitely a case fit for rejection. Based on this expose, the DC of Uttara Kannada district has recommended that the project not be allowed. The District Forest Officer has also found that the claims of MPCL that there are no forests in the submergence area are false, for this area constitutes an assemblage of moist deciduous and evergreen forests, supporting a range of wildlife, including the occasional tiger. Yet there is very high pressure to build this dam.

In addition to being indiscriminately dammed, the Kali River is being polluted by the Dandeli Paper Mills, which throws out large volumes of untreated effluents into

the river. For the communities that depend on this river, adverse impact of the accumulated pollutants has been tremendous. Losses in agriculture, dairy farming and fisheries are a common tale here, and cattle deaths are regularly reported. Farmers in direct contact with the water suffer from a variety of skin diseases caused due to pollution of the river. Very little is known of the impact on wildlife. The concerned regulatory agency, the Karnataka Pollution Control Board has done very little to contain the damage, thereby allowing the mills a free run on its polluting spree. Only recently, due to pressure from local communities under the banner of Kali Bachao Andolan, has there been some response; with the local Assistant Commissioner initiating criminal proceedings against the company. The demand is not a closure of the Dandeli Paper Mills. Rather, it is to get the mill to clean up its operations for the benefit of all including the employees of the mill.

The people of the region, in order to end this misery, are working to build awareness on the threats to

Samrakshana Kendra (PSK), along with several local community organizations and tribal villages has formed the Kali Bachao Andolan (KBA). Panduranga Hegde, leading the KBA, and several others conducted a Padayatra (an awarenessbuilding and protest walk along the entire course of the river) in February this year. Sunderlal Bahuguna, leader of the Chipko Andolan, launched this Padayatra. There has been overwhelming response from local communities to this effort. Environment Support Group (ESG), Bangalore, is an active support organization involved in the KBA.
